Agreement to Participate with Waiver and Release Liability

Disclaimer: Bethalto Bulls Wrestling Club or any of its coaches, board members or club members are not responsible for any injury (or loss of property) suffered by any person while participating, practicing, wrestling or engaging in any other activity whatsoever at any of the Bethalto Bulls Wrestling Club practices, wrestling tournaments or events. This includes the acts or omissions of the Bethalto Bulls Wrestling Club, it's coaches, board members, agents, employees, sponsors, volunteers, owners, or lessor of any premises in which the Bethalto Bulls Wrestling Club participates, practices, wrestles or engages in other club sponsored activity.

In consideration of my being allowed to participate with the Bethalto Bulls Wrestling Club and related events and activities, I hereby release and covenant not to sue the Bethalto Bulls Wrestling Club, it's coaches, affiliates or any of its or their respective officers, directors, representatives, employees, sponsors, volunteers, lessors, instructors or agents for any and all present or future claims resulting from the acts or omissions of Bethalto Bulls Wrestling Club or others listed for property damage, personal injury or wrongful death, arising as a result of my engaging in or receiving instruction in the Bethalto Bulls Wrestling Club programs and the activities incidental thereto, wherever, whenever or however same may occur. I hereby voluntarily waive any and all claims that may be made by me, my family, estate, heirs, agents, representatives, or assigns resulting from the acts or omissions of the Bethalto Bulls Wrestling Club, and its coaches and other above described parties, both present and future.

I am aware that wrestling is a vigorous team and individual sport that at times involves severe cardiovascular stress and violent physical contact. I understand that wrestling involves certain risks, including but not limited to death, serious neck and spinal injuries resulting in complete or partial paralysis, brain damage, injury to virtually all bones, joints, muscles and internal organs, and that equipment provided for my protection may be inadequate to prevent serious injury. _____ Initials

I understand that my participation with the Bethalto Bulls Wrestling Club and subsequent training, practices, events and matches involve activities incidental thereto; including but not limited to travel to and from site, off site travel to other events and activities not affiliated with Bethalto Bulls Wrestling Club. Participation at these other events and activities may be at sites that are remote from available medical assistance and there may be risk from the conduct of other participants. I am voluntarily participating in these activities with full knowledge of the possible dangers involved and hereby agree to accept any and all inherent risks of property damage, personal injury or death. **I understand** that this waiver is intended to be as broad and inclusive as permitted by the laws of the State of Illinois and agree that if any portion is held invalid, the remainder of the waiver will continue in full force and effect. I further agree that the venue for any legal proceeding shall be in the courts of the State of Illinois and that the laws that will apply will be the laws of the State of Illinois.

I affirm that I have read and fully understand the content of the attached Agreement to Participate with Waiver and Release of Liability and am freely signing this agreement, and that I am giving up my legal rights and/or remedies which may be available to me for the acts or omissions of the Bethalto Bulls Wrestling Club, it's coaches or any of the other parties listed above.
